Hello St. John's, it's November and we kick off the month with All Saint's Day. All Saint's Day covers a lot of ground. We utilize the day to honor those from our church who have passed away in the past year. We also honor all of those who have died in Christ that have belonged to our churches over the years. On top of that, we honor all Christians who have died in Christ throughout the ages. That's a lot of people! I'm guessing that many of those people who have passed away never thought of themselves as saints, but they are. The word saint is a funny word or title. If you put it at the beginning of someone's name then you are really saying something. Saints are kind of like the "Hall of Famers" of the Christian world. They lived lives that were so amazing and faith filled that they are still famous today and belong "in the record books". One is Saint Augustine of Hippo. Augustine died around 430 AD but his importance to us is huge. His writings greatly inspired Martin Luther and Luther's rediscovery of ancient truths. Saint Jerome lived at just about the same time as Augustine and he was a "Doctor of the Church". He was really smart, translated the Bible into Latin, and helped us to determine what our modern Bibles should look like. If we didn't have Augustine or Jerome then our Christian history would be different. They are important and there are many others like them. So do you have to be like them to be a saint? Do you have to do something big so that the church will remember you hundreds of years later?

I'm not going to lie, it would be cool to be a saint like Augustine or Jerome. You could even be as cool as Saint Patrick and people could use you as a reason to party, celebrate, and turn rivers green every March. In the kingdom of heaven sainthood is a little bit different then that. It's not an exclusive or famous club. The Apostle Paul was a huge influence on Augustine, and both of them were a huge influence on Luther. Paul called the people of the church saints over and over again. He uses a greek word "hagion" that we translate as saint and Paul uses it in all of his letters. We he uses it he's usually talking about the people in the church. People who are just like you and me. People who believe and put their trust in Christ and have been sanctified through him. That word "hagion" or saint in the Greek dictionary tells us that saints are different from the world, sacred, set apart, holy, likeness of nature with the Lord.

That describes you and I! We are different from the world, set apart, sanctified and every day we are growing more and more into the likeness of nature with the Lord. I don't feel like a saint and I'm not famous but the bible tells me I'm a saint and so are you. So we celebrate the saints in the church now and those who have gone on to be in the presence of the Lord. Then later this month we take time out to give things. Life is good, the Lord is very good, and we use the church calendar to celebrate his goodness.


Sunday School Students and Parents

National Adoption Month

November is National Adoption Month, a time to honor families who have opened their hearts and homes to children and teens. For LSI, it is a time to celebrate the families we support through Foster Care and Adoption, and to raise awareness for the hundreds of lowa children in need of a safe, healthy home.

In 30 counties across western lowa, LSI Foster Care and Adoption recruits, licenses, and supports foster and adoptive families to ensure every lowa child grows up in a safe, stable environment.

But more work needs to be done. According to the most recent federal data, more than 100,000 children in the U.S. are waiting to be adopted from foster care, and thousands of teens age out of foster care every year without a permanent family. Giving Back to Their Community Amber and Donald had always felt called to provide foster care. But any time they would consider taking the leap and starting the process, the thought of "what if?" would leave them feeling stuck. Now, Amber can't imagine life without the children her family has cared for over the years.

Amber and Donald became licensed to provide foster care and adopt children almost seven years ago. Since then, they have provided foster care for 17 lowa children and adopted six. Amber says one of her favorite parts of the experience is seeing her adult children bond with each child who enters their home. "It's crazy to see our 25-year-old so bonded with our two-year-old. We don't label the kids as 'adoptive' or 'biological', they're just all our kids," Amber says. "That bond is just as huge whether it's biological or not." As lowa continues to see a need for more foster and adoptive families, Amber says becoming licensed is one way lowans can give back to their community.

"God gives us all gifts, and parenting and helping in the community seemed to be what He put in our hearts," Amber says. "If you haven't found a place to help in your community, consider foster care and adoption," she says. "It could be exactly what your purpose is."


